user's network, the user can experience a lower cost per bit and a reduced maintenance cost for a correspondingly greater number of subscriber lines. An additional benefit is that many of the pre-existing and commercially available termination and distribution devices can be used. Thus, the user may have fewer expensive and cumbersome termination and distribution devices to purchase and maintain. A related benefit is that the cost of ADSL services can be spread over a greater number of user lines due to the user's ability to have fewer termination and distribution devices.
