Here's a thing you should know about a no-contact order: It's a pretty darn great tool when you're telling your kids to keep away from something really dangerous. A no-contact order means that if you are found in possession of child pornography, your computer can be seized, your communications can be tapped, and you can even lose your freedom for six months. The trouble is, the no-contact order is a very limited tool. It allows for neither electronic monitoring nor searches of your computer. Thus, if you haven't committed a violent crime and are charged under Section 270.30, R.S.Mo., (downloading child pornography), you will likely be able to violate the terms of the order and still walk free, because there is no no-contact order remedy available to the court to address your violation of the order. This is wrong. By not allowing for computer and electronic searches to be considered as part of an order, the statute effectively silences victims of child pornography. For they are the only ones who have the ability to stop a child pornography offender from misusing the Internet. This is especially true for people such as myself who are charged with downloading child pornography and do not reside in the county where the allegations against them arose. The root of this injustice is Section 270.120, R.S.Mo., which describes the conduct prohibited under the criminal statute. An important part of that conduct is that the person "knowingly or intentionally receives, possesses, or views any visual depiction, as defined in subsection (b), of a child or depictions involving children for the purpose of arousing or gratifying the sexual desire of any person." The next sections of the statute criminalize knowingly transferring or viewing a visual depiction of a child that has been transported in interstate commerce or that has actually been mailed, shipped or transported in interstate commerce by any means including the Internet, as well as knowingly using a facility of interstate or foreign commerce to transmit such visual depictions. However, before the possession of child pornography can be charged as a crime, the law requires that the person know the person depicted in the image was a minor. This requirement to know the child was a minor is a huge protection for those who are charged with viewing or possessing child pornography. Once you know the person depicted in the photo or video was a child, you will not even have an option to commit the crime. Rather

in digital courts, for example. "As we know from the debate over bail reform, we need to take a more flexible approach to mental health," said Ms Dorowicz.
