These are free, but we don't have a link to download these versions. The first version is Adobe Photoshop Elements 10, and is currently available as a download (it has a file size of 7.34 GB). Installation process If you already have Photoshop Elements installed on your computer, the Photoshop Elements 10 installation should just walk you through the workflow for doing tasks. You can run Photoshop Elements 10 in an offline mode, which is to say, that you won't be able to import, edit or save any files. This is useful for running the software in the clouds. You also have the option to install a license to a linked Windows account, which means you can use the software either on your computer or a different computer that is connected to that Windows account. If you don't already have Photoshop Elements on your computer, the installation process walks you through the workflow, before asking you to add the software to your computer or computer account. 242 Md. 348 (1966) 219 A.2d 200 GRAHAM v. BALTIMORE GAS AND ELECTRIC COMPANY [No. 157, September Term, 1965.] Court of Appeals of Maryland. Decided February 10, 1966. The cause was argued before PRESCOTT, C.J., and HAMMOND, HORNEY, OPPENHEIMER and McWILLIAMS, JJ. Charles J. Graham, in proper person, for appellant. John T. Bell, with whom were Carl S. Lloyd and Venable, Baetjer & Howard on the brief, for appellee. PER CURIAM: The appellee (Baltimore Gas and Electric Company) instituted an action in the Circuit Court for Baltimore County against the appellant (Mr. Graham) for repossession of an electric range. A jury found in favor of appellee and awarded it \$19.50 actual damages and \$10 punitive damages. Motions for judgment n.o.v. and a new trial were overruled, and the appellant appeals. The only question presented is whether the trial court should have directed a verdict for the appellant on the issue of whether the appellee had given proper notice of intention to take possession. The appellee on July 24, 1963, gave notice to the appellant that it intended to retake possession of the range from the appellant on or before September 2, 1963. The appellant failed to respond and was notified of the appellee's intent to take possession on September 7, 1963. The appellant was given a five day notice to pay the balance due on the range on or before September 12, 1963. There is no evidence that he responded to either notice. It was stipulated that the appellee's \*349 agent was diligent in giving the notice to the appellant. Article 95B of the Code (1963 Repl. Vol.) provides that "where the parties to a conditional sales contract \* \* \* are not living in the same place, either party may notify the other by registered letter addressed to the last-known address of the person to be notified." The appellee argues that the appellant received his notice as late as September 13, 1963, for it was received by mail on that day from a New York address which was the appellant's last known address.
