By Mona Nemer and Joshua Gans The bioethicist James Shapiro reported in the New York Times that medical advances are "increasingly being dependent on the increasingly more politicized peer-review process," and that the process is "as fraught with potential bias as are the deliberations that the jury renders in a criminal trial." The Science of Science article that accompanied the Times piece points to the conflict of interest facing editors of journals: if they publish or perish, they make money whether their papers get accepted or not. Economists might find this counterintuitive, but the fact is, some journals aren't just profitable, they're highly profitable. For example, the Journal of the American Medical Association (JAMA) came out with a substantial profit margin in 2017. There were a number of factors at work, but one of them was the fact that JAMA has recently undergone a "co-branding" with the New England Journal of Medicine. So instead of the usual 50/50 split of profits, JAMA earned 34.5 percent (rather than just the usual 9 percent). Naturally, one can find examples of successful research-based journals at all points in the profit spectrum. But the problem is that, the most profitable

The 1031 Exchange is a type of rollover which is usually used to avoid capital gains taxes. "1031 Exchange" is defined as a method of capital gain deferral or retention. The advantages of the 1031 Exchange are: the ability to defer capital gains taxes, minimize capital gains taxes on the exchange property (exchange), capital gains taxes on the purchased property. Specifically, under the 1031 Exchange, you can retain ownership of one property and roll over the gains into a new property. Before you begin, it's important to understand the qualifying rules for the 1031 Exchange. All properties must be real property, or business

assets that generate passive income. An example would be rental properties that generate rental income (i.e. restaurant, hotel, etc.), however, the main point is that you must be holding real property in order to qualify for a 1031 Exchange.
