Many designers are familiar with the image editing software, but there are many areas of Photoshop that are very unfamiliar to even experienced Photoshop users. Let's have a quick run-through of some Photoshop basics. How to create a new folder Photoshop allows you to create folders with the File > New Folder command. Hold down the Shift key to create a new folder in the active document window and use Shift+Ctrl+N (⌘+ ⌃+ N) to create a new folder in the current Photoshop document. This command works in any Photoshop document and is a quick and easy way to create folders. The icons used in Photoshop are actually the names of folders for File > New Folder: Blank: The blank folder icon Music: The icon used to insert music files Video: The icon used to insert videos Work: The icon used to insert files that contain work product like CAD files. Folders can also be nested (contained) within other folders. For example, a folder containing folders named Pic 1, Pic 2, and Pic 3 can also be contained in a folder called Pictures which has the Pictures folder icon. How to navigate using keyboard shortcuts Photoshop's keyboard shortcuts are very important. Using keyboard shortcuts is less about shortcuts being "intuitive" and more about the practicality of being able to hit certain keys quickly. Photoshop uses the keyboard to navigate more than just the active document window. It uses shortcuts to navigate to other windows, different documents, and even the menu, toolbox, and other things that are available on the screen. Learn a few key shortcuts now and you'll reap the benefits later. Keyboard shortcuts are assigned to tools. For example, keyboard shortcuts for camera in the lens tool are CMD+A

(Command+A) and CMD+T (Command+T). Keyboard shortcuts for menus are assigned CMD+M (Command+M) and CMD+T (Command+T). Open the Keyboard Shortcuts window (there's a menu on the keyboard's menu button, options/shortcuts, and a shortcut for the window) and search for the tool you want to learn keyboard shortcuts for. Once you're in the Keyboard Shortcuts window, you can configure keyboard shortcuts or choose to assign existing shortcuts. The plaintiff seeks appellate review of the lower court's judgment in his favor for \$750.00 against Harry Rhodes and Progressive Life Insurance Company. The plaintiff became the owner of a 1972 Harley Davidson Motorcycle on November 26, 1973. The terms of the purchase were prepared by the plaintiff and the purchase money was taken from him by the salesman. The plaintiff told the salesman he would be selling the motorcycle at a party on December 8th or 9th. Plaintiff received a letter on or about December 3rd from Mr. Rhodes and Progressive Life Insurance Company offering \$1,000.00 if he would "turn in" the motorcycle. The plaintiff testified he was not familiar with the meaning of the term "turn in." He states he was told the new owner would take care of the motorcycle for him. The plaintiff accepted the offer on December 10, 1973 and took the motorcycle to the offices of Progressive Life Insurance Company. Upon delivery of the motorcycle, Mr. Rhodes and Progressive Life Insurance Company presented the plaintiff a bill for \$2,067.00. The plaintiff was unable to pay this amount and he signed a waiver releasing the insurance company from further liability. The plaintiff signed the document and was allowed to leave. He stated he later learned he was not permitted to leave the premises until the documents were notarized. The plaintiff did not receive any documents notarizing the release until after the motorcycle was repaired and he paid the bill. Mr. Rhodes testified he told the plaintiff he would take care of him as a client. The plaintiff advised the salesman he would be selling the motorcycle at a party on December 8th or 9th. He took the bill to the plaintiff's house and left it on the kitchen table where the plaintiff could find it. When the plaintiff failed to pick up the bill, he picked it up on December 15th. It was on the desk in the plaintiff's living room
